TITLE ARMY ACCREDITATION OFFER (AAO)

BACKGROUND & PURPOSE

Accreditation provides proof of transferable knowledge, skills and experience gained by soldiers and officers during Army training and education courses to prospective joiners and civilian employers. Qualifications from the AAO range from Levels 1 to 7 on the Regulated Qualifications Framework and may grant entry to further studies and higher qualifications. The AAO helps Service Personnel (SP) conduct Continuous Professional Development and demonstrate Whole Life Development during their career and afterwards.

KEY TASKS AND TIMELINES

- Army personnel should check eligibility and submit applications to Education Branch, APSG.
- Courses must have been completed within the last three years, although some have a shorter timeline. Legacy courses can be considered depending on the awarding organisation.

Appendix 1 to Annex B – Army Accreditation Offer Application Form

ARMY ACCREDITATION OFFER (AAO) OUTLINE

- 1. **Aim**. The AAO funds civilian accreditation of eligible pan-Army professional development courses¹. Accreditation demonstrates transferable skills and knowledge gained during Army training and education courses. Civilian accreditation can function as an entry point to Further Education (FE) and Higher Education (HE) courses using funding sources such as Standard or Enhanced Learning Credits. Qualifications from the AAO range from Levels 1 to 7 of the Regulated Qualifications Framework. The organisational effect is that the Army's high-quality training is recognised by prospective joiners and civilian employers, thus supporting the full transition pipeline.
 - a. **Eligibility**. The AAO is open to all soldiers and officers, Regular and Reserve, who have completed an eligible course. Personnel may apply for one qualification per course. Awarding organisations require all applications for accreditation to be submitted through Ed Branch due to assurance requirements. Applicants cannot approach awarding organisations directly to accredit the courses listed in this ACO. The course competency must be recorded on JPA before applications are submitted, otherwise the application will be rejected. Accreditation must be applied for within three years of completing an eligible course unless shorter time limits apply. Accreditation options are listed in Annexes C-E.
 - b. **Veterans**. Retired Army personnel are eligible to claim accreditation through the AAO up to 2 years post discharge, subject to the same eligibility requirements above.
 - c. **Overseas Students on British Army Courses**. It is the intention that students on eligible courses from foreign Armies can apply for the AAO with a supporting letter from their course DS stating what course they have completed and when². Policy will be updated concerning eligibility and the application process in due course. Therefore, applicants are advised to wait to submit their applications for accreditation until this change has been confirmed.
- 2. **Eligible Courses**. Accreditation options per course are broken down by accreditation provider and listed in Annexes C-E. These offers are constantly updated as course content is reviewed or rewritten. Multiple accreditation options are available for some courses; applicants should ensure they visit awarding organisations' websites before making their decision as different options will suit different SP depending on their situation. Further advice on choosing between awarding organisations is available on the 'Accreditation and the Army Accreditation Offer' section of the Army Knowledge Exchange (AKX) and the 'Accreditation' page of the Learning and Development Portal (Army) on Defence Connect. Additional personal development advice and support is available from Army Education Centre (AECs). Further details on the comparison between qualification levels can be found on the GOV.UK website.
- 3. **Legacy Accreditation Options**. With the transition of mandatory soldier education from CLM 08 to ALDP, CLM will become a legacy course subject to different 'claim-by' dates depending on the awarding organisation. Full details of City and Guilds (C&G) qualifications, which owns the Institute of Leadership and Management (ILM) are listed in Annex C, whilst the Chartered Management Institute (CMI) options are listed in Annex D. The DAO does not currently accredit any legacy qualifications. In outline, the last date that applications can be submitted to Ed Branch, APSG are:

- a. 25 Jun 21: Applications for CMI accreditation cease to be processed for all courses listed in Annex D, Ser 2. This includes all CLM 08 courses.
- b. 1 Apr 23: Applications for C&G and ILM accreditation cease to be processed for all courses listed in Annex C, Ser 3. This includes all CLM 08 courses.
- 4. **Specific Exclusions.** The following are not included in the AAO:
 - a. Advanced Command and Staff Course (ACSC). ACSC accreditation is paid for by the Defence Academy. Individuals should contact the Defence Academy for further information at LrngDevAsrnc@da.mod.uk.
 - b. **Education Courses Completed More Than Three Years Ago**. All relevant accrediting bodies' assurance strategies state that accreditation cannot be applied for more than three years after the eligible course has been completed. Therefore, these courses are outside of the awarding organisations' specified time window and cannot be accredited.
 - c. **Army Trainer Capability (ATC)**. ATC courses are accredited through a separate scheme and are not eligible for AAO funding. Further details can be found on the Army Trainer Capability page on the <u>AKX</u> or on the Army Trainer Capability page on the Learning and Development Portal on <u>Defence Connect</u>.
 - d. **Memberships**. Awarding Bodies may offer a year's free membership with certain qualifications but there is no funding available for membership after this date. It should be noted that SLCs may **not** be claimed for annual membership fees for institutes or professional bodies³.
 - e. **Directing Staff (DS)**. DS are not eligible to claim accreditation for the courses they teach on.
 - f. **Reimbursement**. The AAO will not refund Army personnel who have already paid for accreditation.
- 5. **Further Opportunities**. Accreditation may be the first step to further educational opportunities, many of which will be eligible for Army and government funding. For example, accreditation could be used to access a fast-track degree, or degree apprenticeship, with a bridging course funded by Standard Learning Credits and a one-year distance learning degree course funded by an Enhanced Learning Credits claim. Further information and advice on similar opportunities and participating further education colleges and universities is available from the applicant's local AEC, the Elective Development page on the <u>AKX</u> and the <u>British Army Website</u>.
 - a. In-Service Opportunities. Further funded opportunities at L7 (Master's) / L8 (PhD) are available to Army personnel through the External Placements (Academic) Programme and the Part-time Post Graduate Master's level Studies at Cranfield University. The Army Higher Education Programme (AHEP) is open to OCdts at RMAS and up to 18 months after they commission and again at ICSC(L) and for up to 6 months after, providing an opportunity to study for a BSc, MSc or MSc Exec in Leadership and Strategic Studies. The Chartered Management Degree Apprenticeship (CMDA) is open to SNCOs and WOs, providing an opportunity to study for a degree in Leadership and Management and gain Chartered Manager Status.
 - b. **Further Education and Higher Education Scheme for Service Leavers (SL)**. SLs can still access the Further Education and Higher Education Scheme if they apply for any of the accreditation options included on the AAO. <u>JSP 822 Part 1 Section 6.6 Para 15</u> states that only qualifications above a **full** Level 4 prevent applicants from accessing the Scheme. In this

instance, a **full** Level 4 qualification is stated as an HNC which is 120 Credits⁴. The relative Credit rating of each qualification can be checked on <u>Ofqual's Register of Regulated</u> <u>Qualifications</u>. However, no qualification included in the AAO is above this threshold. In comparison, the highest Credit earning qualification in the AAO is the CMI Level 7 Extended Diploma in Strategic Management and Leadership which equates to only 66 Credits.

APPLICATION PROCESS

- 1. Applicants are to:
 - a. Identify the qualification for which they are eligible.
 - b. Ensure the course competency listed on JPA
 - c. Apply for only one accreditation option per qualifying course.
 - d. Ensure all relevant details are included on the application form. Incomplete or illegible forms will be rejected.
 - e. Apply within 3 years of completing the qualifying course. This timeline is different for legacy courses, see Annex C and D for more details.
 - f. Decide which qualification is most suitable. Further advice on choosing between awarding organisations is available on the 'Accreditation and the Army Accreditation Offer' section of the Army Knowledge Exchange (AKX) and the 'Accreditation' page of the Learning and Development Portal (Army) on Defence Connect. Additional personal development advice can be sought from the applicant's local AEC, the location and contact details of which can be found on the 'Find your AEC' section of Learning and Development Portal (Army) on Defence Connect.
- 2. There are two ways to submit applications:
 - a. Fill out the <u>Army Accreditation Offer Application Form</u> on MS Forms from either a MODNET terminal or Personnel Electronic Device (PED). The application form takes around 3 minutes to complete, partially completed forms cannot be saved.
 - b. Fill out the application form at Appendix 1 to Annex B and email it to APSG-EdBr-Accreditation@mod.gov.uk. Scanned copied are acceptable.

- 3. Education Branch is bound by MoD/Army Policy and the data Protection Act 2018 (DPA 18)⁵. By applying for the AAO, you consent to Education Branch sharing your personal data with the awarding organisation you nominate to accredit your course. In processing personal data, Education Branch is acting on behalf of the MoD; where the MoD is the Data Controller. Education Branch has put policy and processes in place to ensure processing is conducted appropriately, safely and by trained administrators in accordance with the DPA 18 Six Principles.
- 4. Education Branch will only collect personal data that is necessary to deliver the service specified within this project/application. The minimum necessary data will be passed to the accreditation provider by Education Branch for the purposes of issuing certification which consists of the following: surname, forename, date of birth, gender, postal address, civilian email address.

Qualification requested

Only one qualification may be requested per course and it must have been completed within the last 3 years. Ensure the course competency is listed on JPA. Only enter a qualification that is achievable from the course you have stated in the *Qualifying course details* box at the top. Failure to do this will necessarily result in your application being rejected.

Personal details for anonymised statistics purposes

Service Number will not be included in data analysis but is required to provide a means of identifying an individual through JPA in case of some error in the certification process (e.g., your certificate is paid for but not received), and to ensure that Education Branch can identify total number of applicants. Each soldier may apply for one qualification per course, and therefore could appear more than once in statistics purposes. Service Numbers are unique to the individual and so can be used to filter out multiple applications from the same person.

CITY AND GUILDS AND INSTITUTE OF LEADERSHIP AND MANAGEMENT (C&G and ILM)

- 1. **Introduction**. The Institute of Leadership and Management (ILM) and City and Guilds (C&G) are part of the same organisation. All ILM and C&G's accreditation options are nationally recognised Ofqual regulated qualifications⁶. You can select only one option per eligible course.
- 2. **OFQUAL Regulated Qualifications**. ILM and C&G accreditation directly translates the leadership, skills and knowledge gained through military training courses into a civilian qualification making them more meaningful to employers without any additional work. Your civilian qualifications grow alongside your military career, creating a CPD portfolio that will demonstrate capabilities and highlight transferable skills. Accreditation with either ILM or C&G gives you access to their membership area for one year following accreditation. Here you can access numerous leadership and management resources to continue your professional development.
- 3. **Legacy Accreditation Options**. These options are for CLM 08. They expire on 1 Apr 23. After which, ILM and C&G accreditation will consist only of the options listed at Annex C, Section 4. Applications for these courses will not be accepted after 1 Apr 23.

CHARTERED MANAGEMENT INSTITUTE (CMI)

- 1. **Introduction**. CMI offers two options for accreditation: the first is a nationally recognised Ofqual regulated qualification which requires additional work, the second is a certificate of recognised learning which is not a nationally recognised qualification. You can select only one option.
 - a. **Ofqual Regulated Qualifications**. To apply for a CMI qualification requires additional work. The additional modules will be sent to the email address you specify on your application. CMI will contact you within 6 weeks with the additional modules to be completed. Modules must be completed within 9 months and returned to ea.marking@managers.org.uk.
 - b. **Recognised Certificates**. The certificate of recognised learning is a suitable option if you want to access CMI's management resources, networks and member benefits for the year following accreditation without undertaking additional work. However, this is not a formal qualification.
- 2. **Legacy Accreditation Options**. These options are for courses completed before 1 Mar 21. They expire on 25 Jun 21. After which, CMI accreditation will consist only of the options listed at Annex D, Section 3. Applications for these courses will not be accepted after 25 Jun 21.
